## Admissibility Criteria

Please note: If the admissibility criteria outlined below are not fully met, your visa application will be deemed inadmissible. In such cases, the Embassy of Switzerland will according to Art. 9(3) Visacode:

- Return your application form and any documents you submitted;
- Destroy any biometric data collected during the application process;
- Reimburse the visa fee; and
- Cease further examination of your application.

<b>1. Admissible submission period</b> Applications shall be lodged no more than six months, and for seafarers in the performance of their duties no more than nine months, before the start of the intended visit, and, as a rule, no later than 15 calendar days before the start of the intended visit.	<input type="checkbox"/>	<input type="checkbox"/>
<b>2. <b>3. Travel Document</b> <ul style="list-style-type: none"> <li>• its validity shall extend at least three months (3) after the intended date of departure from the territory of the Member States or, in the case of several visits, after the last intended date of departure from the territory of the Member States. However, in a justified case of emergency, this obligation may be waived;</li> <li>• it shall contain at least two blank pages;</li> <li>• it shall have been issued within the previous 10 years.</li> </ul> <p><b>The following documents must be enclosed with the application:</b></p> <ul style="list-style-type: none"> <li>• The original valid passport and one copy of all relevant passport pages (data on <b>pages 2 &amp; 3</b>;</li> <li>• pages containing previous Schengen / UK / USA / Canada visas from the last five years – (no photocopies of empty pages).</li> <li>• In case of previous refusals, please include a photocopy of the negative decisions</li> <li>• The passport must contain at least two empty pages.</li> <li>• The passport must be valid for at least 3 months beyond the intended departure date from the Schengen States.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
<b>4. Photograph</b> <ul style="list-style-type: none"> <li>• One recent (taken within the last 6 months) <b>ICAO-compliant photo</b>.</li> <li>• White or light background, in colour, with no shadows.</li> <li>• Size: 35mm x 45mm (standard ICAO dimensions).</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
<b>5. Biometric data (fingerprints)</b> <ul style="list-style-type: none"> <li>• Biometric data have to be collected for first time travellers or travellers whose biometric data was collected more than 59 months ago.</li> <li>• Travellers with valid biometric data (taken less than 59 months ago) are exempted of lodging the application in person. <b>1. Invitation letter</b> If an inviting party is financing your stay in the Schengen area the host must provide an invitation letter / documents containing: <ul style="list-style-type: none"> <li>• First name, family name, exact address, e-mail, phone number of the host and specifying the relationship between the visitor and the host</li> <li>• The duration as well as the places and the reasons of the stay in the country to be visited</li> <li>• The host's responsibilities for all expenses incurred in the country to be visited, if the host is the sponsor of the stay</li> <li>• Host's passport copy (if Swiss, national) or residence permit (if other nationality)</li> <li>• Host's bank statement of the last 6 months</li> <li>• Host's salary slip of the last 6 months</li> <li>• Host's Apartment rental contract</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>	<input type="checkbox"/>
<b>2. Declaration of Guarantee:</b> <ul style="list-style-type: none"> <li>• <b>Declaration of guarantee from a host living in Switzerland or Liechtenstein</b> the applicant may receive upon discretion of the Embassy of Switzerland the form after a positive preliminary notice. The applicant has to forward it personally to the guarantor in Switzerland. The subsequent procedure is explained on the backside of the Declaration of guarantee for Switzerland.</li> </ul> <p><b>Note: A visa may be refused even with a declaration of guarantee. ## Additional General Information

---

- ❖ **Note for children and spouse of Swiss and EU/EFTA nationals:** Please only provide the following documents: Application form, photographs, original passport, photocopy of passport, photocopy of valid Swiss or EU/EFTA passport (of spouse/parent) and proof of family relation (copy of marriage or birth certificate / Family Registration Certificate).
- ❖ Visa applications from non-residents in Pakistan will only be accepted if proof of legal residence can be provided. Pakistani nationals, residing in another country than Pakistan, have to submit their applications to the Swiss representation competent for their place of residence.
- ❖ No documents will be returned after submission and verification by this Embassy.
- ❖ During the visa application process, questions regarding your visa application may **only** submitted by email to: [islamabad.visa@eda.admin.ch](mailto:islamabad.visa@eda.admin.ch), please do allow time for a reply.
- ❖ In case of refusal, the visa fees are not refundable.
- ❖ Decision on the application will normally take place within 15 calendar days after lodging the application.
- ❖ All documents must be in English, translated to English by a sworn-in translator, or in an official Swiss language (German, French, Italian) within the last 6 months.
- ❖ All copies must be format A4

## Important Information

---

The Embassy of Switzerland explicitly reserves the right

- to request more information or additional documents.
- to verify the contents and authenticity of the documents presented.
- to send the application to the Swiss Federal Authority for decision.
- to refuse a visa based on incorrect/false/incomplete declarations or on forged documents.

### Passing the border:

The border authorities are obliged to examine whether the conditions for the traveller's entry still apply. If the prerequisites for entry no longer apply or if you are unable to provide the relevant evidence, you may be refused entry although you are in possession of a valid visa. **It is therefore strongly recommended that you carry copies of the documents which you supplied with your visa application.**
